The above stated intentions will be carried out in the manner applied for and in accordance with plans, specifications, and/or maps filed with the Oak Park City Engineer as part of this application and if said permit is granted, the above named applicant agrees to do the following:

1. Notify the City Engineer at least twenty- four (24) hours prior to the commencement of operations covered by this permit.
2. In any and all operations under this permit, meet all requirements of the City of Oak Park, Michigan and supplemental specifications set forth on the reverse side of this application and permit.
3. Take, provide and maintain all necessary precautions to prevent injury or damage to persons and property from operations covered by this permit and use safety devices which are approved by the City of Oak Park, Michigan.
4. Save harmless the City of Oak Park, Michigan against any and all claims for damages arising from operations covered by this permit and upon request, furnish proof of insurance coverage for the term of this permit for not less than \$100,000 personal injury and not less than \$100,000 property damage for operations covered by this permit.
5. **Furnish a performance bond acceptable to the City of Oak Park, Michigan and in compliance with all requirements of law, or cash bond if required by the City Engineer with this Application for Permit, in an amount to be determined by the City Engineer, and not less than \$3000.00 that is to remain in effect for a period of not less than one (1) year from the date of this application.**
6. Surrender the permit herein applied for, cease operations and surrender all rights thereunder whenever notified to do so by the City Engineer because of his need for the area covered by the permit or because of default in any of the conditions of this permit.
7. Submit a cash deposit in an amount to be determined by the City Engineer and not less than \$300.00 to reimburse the City of Oak Park, Michigan for any and all costs for inspection and any other costs associated with the operations covered under this permit. After satisfactory completion of this construction and upon presentation of a City of Oak Park, Michigan receipts, said cash deposit will be returned less any expense incurred.
8. Immediately remove, alter, relocate at the applicant's own expense the facility for which this permit is granted, if requested to do so by the City Engineer. Upon failure to remove, alter, relocate or surrender the facility pursuant to the request of the City Engineer. reimburse the City of Oak Park, Michigan for all costs incurred in doing the same.
